TENDER NOTICE

Sealed Tenders are invited for hiring of light motor A/C vehicle in the following type/model on contract basis for a maximum period of 12 months for the use of the Smart City Thiruvananthapuram Limited. The conditions and details are attached to the Tender form and Tender form can be available from SCTL Office, Thiruvananthapuram during the office hours.

Category of Vehicle: 1. Swift Desire or any other vehicle in the similar class. (Full option vehicle). The Tax, insurance and all other compliances should be updated.

2. INNOVA (Full option vehicle). The Tax, insurance and all other compliances should be updated.

The first registration of the vehicle should on or after 01.01.2017. Fresh vehicle will also be considered, subject to the condition that if it gets the tender, the new vehicle must be provided within 10 days, failing which the tender gets disqualified.

The hire charges should be quoted in monthly rate inclusive of all applicable taxes and charges. The contractor should provide the drivers wages, fuel and maintenance of the vehicle. The quoted vehicle must be fuel drawn vehicle and the hire may be quoted with fuel charges. The unused kilometers will be carry forwarded for subsequent months over 3 months block period (3 x 2000 = 6000) and additional kilometers over 6000km for each 3-month period shall be paid @Rs. 15/- per km.
