1. Terms & Conditions:

- A. Envelope should be super-scribed “Quotation for the LCD/LED/DLP Projector, Tripod Mount, projector screen against Inquiry No. SCTL/Proc/IT-DER-21/2018” Due on **21/04/2018 at 3:00 pm**. *Quotations need to be submitted by speed post/registered post or by e-mail to the office of SCTL Thiruvananthapuram.*
The quotations received after this deadline shall not be entertained under any circumstances whatsoever.
In case of postal delay this Institute will not be responsible.
- B. Quotations must be in the prescribed Performa and forwarding letter on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized dealer.
- C. Rates must be quoted with respect to the prevailing domestic taxes. The rates must be quoted in figures as well as in words.
- D. In general no overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected. However, except rate all cuttings and over writings must be signed by the authorized person of the firm.
- E. The rates quoted must be valid for **60 days** minimum from the date of submission of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- F. RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
